- (1) **Section 209 of the New York State Tax Law (State Income Tax)** - The applicable rates and charges for service under all service classifications of P.S.C. No. 2 ELECTRICITY, shall be increased by dividing such rates and charges by a surcharge factor of 1.0060 pursuant to General Information Section 18.
- (2) **Sections 209-b and 186-c of the New York State Tax Law (Metropolitan Transportation Authority Business Tax Surcharge)** - The applicable rates and charges for service under all service classifications of P.S.C. No. 2 ELECTRICITY, including the effect of the surcharge factor shown in (1) above, shall be increased by dividing such rates and charges by the following applicable surcharge factors pursuant to General Information Section 18:
