STATEMENT OF INCREASE IN RATES AND CHARGES

Applicable to Billing under all Service Classifications  
of the Schedule for Electric Service of

**ORANGE AND ROCKLAND UTILITIES, INC.**

- (1) The rates and charges for service under all service classifications of P.S.C. No. 2 ELECTRICITY, shall be increased by dividing the total of such rates and charges by the following factors pursuant to General Information Section 18(C):
